Requirements for the Qualifying Clinic:

- 1) All participants will participate in Showmanship in their respective disciplines, and in full show attire. The horse should be clean and show ready. Banding, braiding, and hoof polishing are desirable. The participant will receive feedback on the personal attire and horse grooming. Horses need to appear as if they are going to a show.
- 2) All horses will be measured and the riders given a card with that information. This card is necessary to compete in the state show.
- 3) During lunch, we will provide more information on the state show rules and regulations. All participants will be expected to attend this session. NOTE: Lunch is not included in the fee. Food and drinks will be available for purchase all throughout the day.
- 4) All riders will be required to wear a helmet at all times when mounted.
- 5) All participants will need to have a signed **Equine Waiver** form, a **Code of Conduct** form, and a **completed health form**. All horses will need a current negative Coggins. These can be obtained prior to the clinic, so please have these ready.
- 6) All riders will receive feedback on each class entered.
- 7) Fees: **\$25 for 4-H participants. \$35 for all others.** Must be paid before participating. RSVP So we can be prepared!!

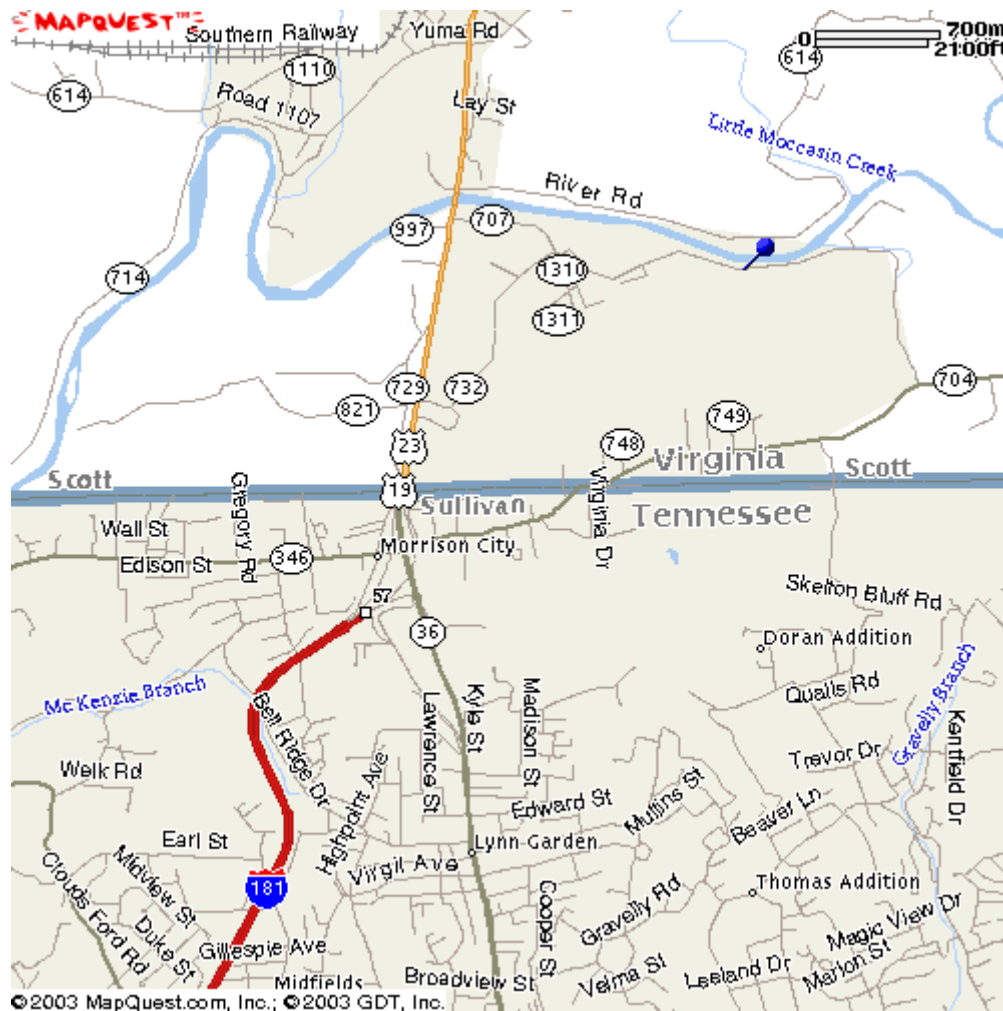

# Directions to the Malone Barn



Take I-181 North (Hwy23) from Stone Drive (Hwy11W). Go 2.5 miles North, stay left at the split, taking the Gate City Hwy 23 North exit.

(Note: I-81 will take you to Hwy 11W in Bristol)

Stay on Hwy 23 for 0.9 miles. Take a right on Rd 707, just past the Beauty Salon. On the left is White's store and Burgers R Us. If you cross the river you have missed the turn.

Stay on Rd 707, veering to the left. The 2<sup>nd</sup> barn on the left is 0.8 miles from Hwy 23.
